Recommendations & regulations

In order to meet requirements and for a smooth return of empties please follow the below listed recommendations.

- All empties are to be stored in a clean and dry environment prior to their return to Dahrén.
- Use only standard formatted pallets when returning empties e.g EUR pallet size 1200×800 mm.
- If possible, no reels should stick outside the pallet's outer edges in order to prevent damages during handling/transportation.
- When necessary, place an intermediate layer of cardboard between each layer of reels to ensure good stability.
- Make sure that only one reel type is packed per pallet.
- All reels must be empty up on their return.
- Finish the top with a sheet of wood and secure the pallet load with at least two straps, preferably nylon/plastic straps.
 No pallets are to be used as a finishing top of a packed pallets with empties.

Discrepancies & conditions for credit

The basis and criteria for Dahrén when performing quality control and cleaning returned empties are:

- The returned items must have originated from Dahrén,
- The returned items after cleaning must meet the Dahrén standards to go into production and must meet the general customer requirements for delivery.
- Only empties that can be identified with an original Dahrén label will be credited.
- Empties must be empty reels that are returned with wire will not be credited nor will any compensation for wire be credited.
- Damaged reels and other packing materials that are damaged will not be credited.
- Reels and packaging material not approved by Dahrén will not be credited. E.g below
 - Reels/Containers written on with marker or felt pen
 - Reels with permanent labels that will not come off
 - Adhesives that will not come off during regular cleaning
 - Cuts to the reel edge or reel core
 - Heavily dirty Reels/Containers
 - Wet wooden packaging materials
- Reels and packaging materials that are not approved by Dahrén will be scrapped. Any other handling of not approved material will need to be agreed in advance and may come with additional handling fees.

250/400 without bell


1 Layer = 13 pcs

Place a sheet of wood as an intermediate layer between each layer of container

Finish the top with a sheet of wood (no pallet may be placed as a finishing top of any stack). Secure the load by using at least two nylon straps firmly tightend.






A250/400 container

1 Layer = 11 pcs

3 Layers in total = 33 pcs

Place a sheet of wood as an intermediate layer between each layer of container





K250 reel


1 Layer = 14 pcs

8 Layers in total = 112 pcs

Place a cardboard sheet as an intermediate layer between every second layer of reel

Finish the top with a sheet of wood (no pallet may be placed as a finishing top of any stack). Secure the load by using at least two nylon straps firmly tightend.






315/500 without bell

A315/500 container


1 Layer = 6 pcs

Place a sheet of wood as an intermediate layer between each layer of container

Finish the top with a sheet of wood (no pallet may be placed as a finishing top of any stack). Secure the load by using at least two nylon straps firmly tightend.






K355 reel

1 Layer = 6 pcs + 2 pcs in the centre

8 Layers in total = 62 pieces

Place a cardboard sheet as an intermediate layer between every second layer of reel





A400/630 container


1 Layer = 3 pcs

2 Layers in total = 6 pcs

Each layer is finished with a sheet of wood

Finish the top with a sheet of wood (no pallet may be placed as a finishing top of any stack). Secure the load by using at least two nylon straps firmly tightend.






A400/630 reel

500/800 reel


1 Layer = 3 pcs

2 Layers in total = 6 pcs

Place a sheet of wood as an intermediate layer between each layer of container

Finish the top with a sheet of wood (no pallet may be placed as a finishing top of any stack). Secure the load by using at least two nylon straps firmly tightend.






K500 reel

1 Layer = 3 pcs

7 Layers in total = 21 pcs







Returning empties process

dahrén

In order for a smooth return and handling of empties the below process need to be followed by all parties involved.

The Customer packs the empties according to the Dahrén Pallet Packing & Stacking Recommendations.

The Customer sends a notice "Return of empties" by e-mail to inbound.sweden@dahrengroup.com or to inbound.poland@dahrengroup.com and attach a detailed packing list in pdf-format to the notice. Choose country for returning empties according to where the majority of your delivery was sent from.

The Customer transportation sure the Return Reference No. i a shipment refe
